TRADING STATEMENT

The Board of Directors of British American Tobacco (Zambia) Plc (“the **Board**”) wishes to advise the Shareholders that for the period ending 30 June 2024, the basic earnings per share is 67% higher than that of the corresponding period last year for the Company.

This increase is due to higher operating profit resulting from increased revenue driven by optimal pricing strategy implemented during the period, which was partially offset by higher cost of operations mainly due to local currency devaluation.

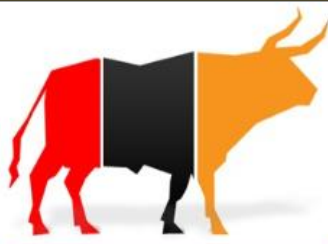
